- Appointed by Nebraska Attorney General with input from Nebraska's Governor as counsel in four cases to represent Nebraska's Governor and other state officials in education funding litigation.
- *Douglas County School District 0001 A/K/A Omaha Public Schools (OPS), The Nebraska Schools Trust, et al., v. Michael O. Johanns, in his official capacity as Governor of the State of Nebraska, et al., Doc. 1028, No. 017 (Douglas County, Nebraska). **Plaintiffs voluntarily dismiss all claims after five years of discovery with trial approaching.*** Appointed Special Assistant Attorney General to defend the Nebraska Governor and all other defendants in a lawsuit filed by the Omaha Public Schools and others challenging the constitutionality of Nebraska's system of funding public elementary and secondary schools. Plaintiffs' experts allege that at least an additional \$750 million per year must be spent on K-12 public education in Nebraska. District Court dismissed plaintiffs' adequacy claims.
